C/W AD 71-09-07 R1 Exhaust manifold heat exchanger IAW inspection instructions, due at 5087 or next annual inspection. Replaced old hyd lines with new. Jacked aircraft. Removed all wheel and brake assemblies and inspected for serviceability and signs of damage. Replaced both sets of main landing gear wheel bearings and races. Replaced brake pads on LH side. Serviced hyd system. Swung gear several times to bleed system. Emergency extension check good. Installed all wheel and brake assemblies back onto aircraft. Serviced nose strut with 5606 hyd fluid and nitrogen. Inspected aircraft exterior for signs of damage, no defects noted. Installed new emergency gear plastic trim panel. Tested all aircraft lights, ops check good. Checked ELT IAW 91.207 (d), no defects noted batt due FEB 2028. Inspected and lubricated all flight controls. Found broken lower door hinge on pilot side. Installed new door hinge. Repaired cargo door steward bracket. Installed aircraft interior. Installed all inspection plates and panels. All work done IAW Cessna 210 AMM and AC 43.13 apex D
